Annual Report of Linked Firm Service Penalty Revenue Credits

Dear Ms. Bose:

Enable Gas Transmission, LLC ("EGT"), pursuant to Section 31.4 of the General Terms and Conditions ("GT&C") of its FERC Gas Tariff, Ninth Revised Volume No.1 ("Tariff"), and Section 154.502 of the regulations of the Federal Energy Regulatory Commission ("Commission"), herewith respectfully submits for filing its Annual Report of Linked Firm Service Penalty Revenue Credits ("Report") for the Penalty Base Period ending July 31, 2020.

GT&C Section 31.4 requires that EGT annually credit to eligible Linked Firm Service shippers any Linked Firm Service Penalty Revenues recovered or collected during the preceding twelve month Penalty Base Period ending July 31. As defined in GT&C Section 31.2, Linked Firm Service Penalty Revenues include all specified penalty revenues recovered or collected during the applicable Penalty Base Period, less the penalty costs associated with such penalties. Eligible Linked Firm Service shippers are those shippers that were unable to flow all or a portion of their nominated Linked Firm Service capacity on a specific day during the applicable Penalty Base Period due to the failure of the linked Rate Schedule FT-2 shipper to perform as obligated.

For the Penalty Base Period ending July 31, 2020, EGT did not recover or collect any Linked Firm Service Penalty Revenues. EGT therefore will not provide any Linked Firm Service Penalty Revenue Credits for such Penalty Base Period.

Additionally, GT&C Section 31.4 requires that EGT annually notify eligible shippers of applicable credit amounts for the preceding Penalty Base Period by November 1. A copy of this Report is being posted on EGT's website contemporaneously with this filing.
