Commercial

EVP, US Gas Pipelines

Responsible for the overall planning, marketing, and business development efforts of the Pipelines' Commercial Groups in the implementation of long and short-term business planning, development, and deal origination. Responsible for overseeing the Regulatory Affairs, Gas Control, Facility Planning, the Pipelines' linepack /gas inventory, and Customer Service functions. Coordinates the availability and pricing of pipeline capacity with Marketing and Business Development.

Vice President, Commercial Operations (FGT – Western Division)

Responsible for the marketing and business development efforts of the Pipeline Commercial Group in the implementation of long and short-term business planning, development, and deal origination. Responsible for overseeing the Gas Control and Facility Planning functions.

Vice President, Interstate & Optimization (EGT/MRT/Gulf Run)

Responsible for the Optimization of Interstate assets and short-term deal origination and Storage optimization.

Vice President, Marketing (FGT – Market Area)

Responsible for the marketing and business development efforts of the Pipeline Commercial Group in the implementation of long and short-term business planning, development, and deal origination.

Vice President, Interstate Marketing and Business Development (TW / PE / TGC / TIGER / Gulf Run / Rover / EGT / MRT)

Sr Manager, Commercial Optimization (EGT / MRT/ Gulf Run)

Directs the commercial optimization efforts in management of the Pipeline's transportation and storage services and strategies that meet customer service requirements.

Lead Analyst, Commercial Optimization (EGT / MRT/ Gulf Run)

Provides analysis of marketing and business development efforts in the management of the Pipeline's transportation and storage services to meet customer service requirements.

Director, Sales (FGT)

Responsible for providing service and maintaining good relations with customers, assisting in negotiations of service agreements, working with customers to identify concerns, resolving issues and providing information to explain company procedures, positions, and philosophies. Evaluates and negotiates day-to-day transportation and/or construction agreements with other pipeline companies, producers, gas marketers and end-users, as required. Responsible for revenue reporting as required.

Sr Manager / Manager, Sales (FGT)

Responsible for providing service and maintaining good relations with customers, assisting in negotiations of service agreements, working with customers to identify concerns, resolving issues, and providing information to explain company procedures, positions, and philosophies. Evaluates and negotiates day-to-day transportation and/or construction agreements with other pipeline companies, producers, gas marketers and end-users, as required.

Sr Manager, Market Competitive Analysis (TW / TIGER / FGT / PE / TGC / Rover / Gulf Run / EGT / MRT)

Responsible for monitoring the company's competitors, customers, and the industry to maximize revenue. Supports Development group considerations related to existing business, new business opportunities and investment decisions.

Executive Account Manager (Gulf Run / Tiger / TW)

Responsible for providing service and maintaining good relations with customers, assisting in negotiations of service agreements, working with customers to identify concerns, resolving issues, and providing information to explain company procedures, positions, and philosophies.

Sr Account Manager (TW / Tiger / Gulf Run / PE / TGC / Rover / EGT / MGT), Account Manager, Specialist - Offshore (PE / TGC / Rover), Commercial

Responsible for providing supervision to Gas Control Team in the scheduling of transportation services and the resolution of scheduling/operational problems.

Manager, Engineering (Gas) (FGT)

Responsible for providing supervision to Gas Control Team in the scheduling of transportation services and the resolution of scheduling/operational problems.

Lead, / Gas Controller / Sr. Analyst, / Technical Systems / Gas Controller / Pipeline Controller A, B, C, (TW / TIGER / FGT / PE / TGC / Rover / Gulf Run / EGT / MRT)

Responsible for approval of firm transportation capacity requests. Operations & Operations Support (TW / TIGER / FGT / PE / TGC / Rover / Gulf Run / EGT / MRT)

Sr Vice President, Operations

Responsible for the overall operations of the pipeline systems including compressors, auxiliary equipment, and control systems. Responsible for overseeing those responsible for maintenance scheduling, reliability program and fuel use evaluation and prime mover performance. Oversees operations to insure safety compliance and optimal use of facilities to meet system demands.

Vice President, Operations

Responsible for the day-to-day operations of the pipeline system including compressors, auxiliary equipment, and control systems. Responsible for maintenance scheduling, reliability program and fuel use evaluation and prime mover performance. Works closely with gas control to insure optimal use of facilities to meet system demands.

Sr Director, Director, Operations

Responsible for directing, planning, and controlling the continuous and safe operation, maintenance, and improvement of the field operations.

Sr Manager, Manager, Operations

Responsible for managing field operations personnel to accomplish the continuous and safe operation, maintenance, and improvement of the field operations.

Manager, Construction

Responsible for managing construction projects of the company pipelines.

Sr Manager, Manager, Engineering

Responsible for management of engineers who are responsible for the planning, design, and construction of medium to large capital and expense projects.

Sr Manager, Operations Engineering

Responsible for management of engineers and construction personnel responsible for the planning, design, and construction of medium to large capital and expense projects.

Vice President, Asset Integrity

Responsible for directing the pipeline integrity department in areas of pipeline operations that include pipeline integrity, material quality assurance/control, metallurgy, and welding.

Sr Director, VP Technical Services, VP EHS/ OE, Sr Manager, Manager, Safety/ Technical Services

Responsible for directing the technical services department in all technical areas of pipeline operations including regulatory compliance, control room management, asset management and reliability, underground storage, GIS and engineering records, damage prevention, safety, and aerial patrol.

Sr. Manager, I&E

Responsible for instrumentation and electrical support for the transmission, gathering and processing assets.

Sr. Director, Director, Underground (U / G) Storage

Responsible for all underground storage facility operations.

Manager, Underground (U / G) Storage

Responsible for managing underground storage facility operations.

Project Manager, Underground (U/G) Storage

Responsible for all underground storage facility projects.

Sr. Director, Director, Technical Operations

Responsible for directing and/or managing technical aspects of pipeline and compressor operations.

Sr. Manager, Manager, Reliability

Responsible for the physical asset management of the companies' engine, compressor and auxiliary equipment maintenance and reliability programs.

Sr. Director, Director, Sr. Manager, Manager, Sr. Project Manager, Pipeline Integrity (Material Weld QA / QC, Services, Interstate)

Responsible for directing and planning the safe day-to-day regulatory compliance.

Sr. Manager, Manager, Control Room Management

Manages the 'Control Room Management' program for all control centers. Participates in new asset integration, root cause analysis for control involvement related to incidents / accidents, point to point testing protocol, and aware of downtime – both scheduled and unscheduled.

Manager, Regional Systems

Responsible for monitoring greenhouse gases at compressor stations and to identify pipeline leaks in the system.
