Gulf Run Transmission, LLC ("Gulf Run") hereby electronically submits for eFiling with the Federal Energy Regulatory Commission ("Commission") its Annual Report of Operational Purchases and Sales of Gas ("Annual Report").

STATEMENT OF NATURE, REASONS AND BASIS

Pursuant to Section 6 of the General Terms and Conditions ("GT&C") in its FERC NGA Gas Tariff, Original Volume No. 1 ("Tariff"), Gulf Run is to file an annual report by May 1 of each year of all system operational purchases and sales of gas for the 12-month period ending December 31 of the previous year ("Annual Period"). Gulf Run is to include in its annual report the source, the date of transaction, the volume, the purchase or sale price, the costs and revenues from the transactions, the disposition of the associated costs and revenues and an explanation of the purpose of the transaction.

Pursuant to GT&C Section 6, Gulf Run provides herein documentation for the calculations of the miscellaneous purchases and sales of gas subject to GT&C Section 6 for the period January 2023 through December 2023.

Appendix A

Appendix A shows the detail required for each miscellaneous purchase and sale of gas, including the source, the date of transaction, the volume, the purchase or sale price, the costs and revenues from the transactions, the disposition of the associated costs and revenues and an explanation of the purpose of the transaction.
