Dear Ms. Bose:

Enable Mississippi River Transmission, LLC ("MRT"), pursuant to Section 34 of the General Terms and Conditions of its FERC Gas Tariff, Sixth Revised Volume No.1 ("Tariff"), and Section 154.502 of the Commission's Regulations, herewith respectfully submits for filing its Annual Report of Penalty Revenue Credits ("Report"), covering such activity during the twelvementh reporting period ending July 31, 2021 ("Accrual Period").

Section 34 of the GT&C requires MRT to credit to eligible firm customers penalty revenues collected during the Penalty Base Period (August 1, 2020 through July 31, 2021) and that notice of such refunds be provided to the eligible customers on or before November 1st of each year. Pursuant to Section 34 of the GT&C, MRT will calculate revenue credits if the total Penalty Crediting Revenues, including any Penalty Crediting Revenues carried forward from prior Accrual Periods, exceed \$250,000. For the Penalty Base Period ended July 31, 2021, MRT's penalty revenues total was \$253,010.27. Accordingly, this amount, plus interest calculated in accordance with Section 154.501 of the Commission's Regulations, will be credited back to Firm Customers pursuant to Section 34 of the GT&C of MRT's Tariff.

Specifically, this filing provides the Commission with a report of all penalty revenues collected by MRT during the Accrual Period, including Penalty Crediting Revenues carried forward from prior Accrual Periods, to be credited back to its Firm Customers pursuant to Section 34 of the General Terms and Conditions of MRT's Tariff. Appendix A reports the penalty revenues collected pursuant to (1) Rate Schedule PALS, Section 5.2(a); (2) Rate Schedule FSS, Sections 3.4 and 4.3; (3) General Terms and Conditions, Section 8.3(d); (4) General Terms and Conditions, Section 9; (5) General Terms and Conditions, Section 10.3(d) (revenues attributable to imbalances greater than 1,000 Dth and five percent, excluding revenues from imbalances pursuant to Section 10.3(d)(iv) and (vii)); and (6) General Terms and Conditions, Section 13.2. Appendix B reports the allocation of the penalty revenues by customer. Appendix C provides the interest calculation.

Penalty revenue credits were reflected on the customers' invoices that were issued on October 28, 2021. Pursuant to Section 34 of the General Terms and Conditions, interest has been calculated from the date on which credits were scheduled to take effect for the recently concluded Accrual Period in accordance with 18 C.F.R. Section 154.501 through October 28, 2021. For Penalty Crediting Revenues carried forward from prior Accrual Periods, interest has been calculated from the end of the Accrual Period in which the Penalty Crediting Revenues were collected through October 28, 2021. Penalty revenue credits are allocated among customers based on firm transportation revenue during the recently concluded Accrual Period.

On October 25, 2021, a copy of this report was served upon those customers listed on Appendix B in accordance with Section 154.502(c)(2). This filing has also been posted as required by Section 154.502(d) of the Commission's Regulations.

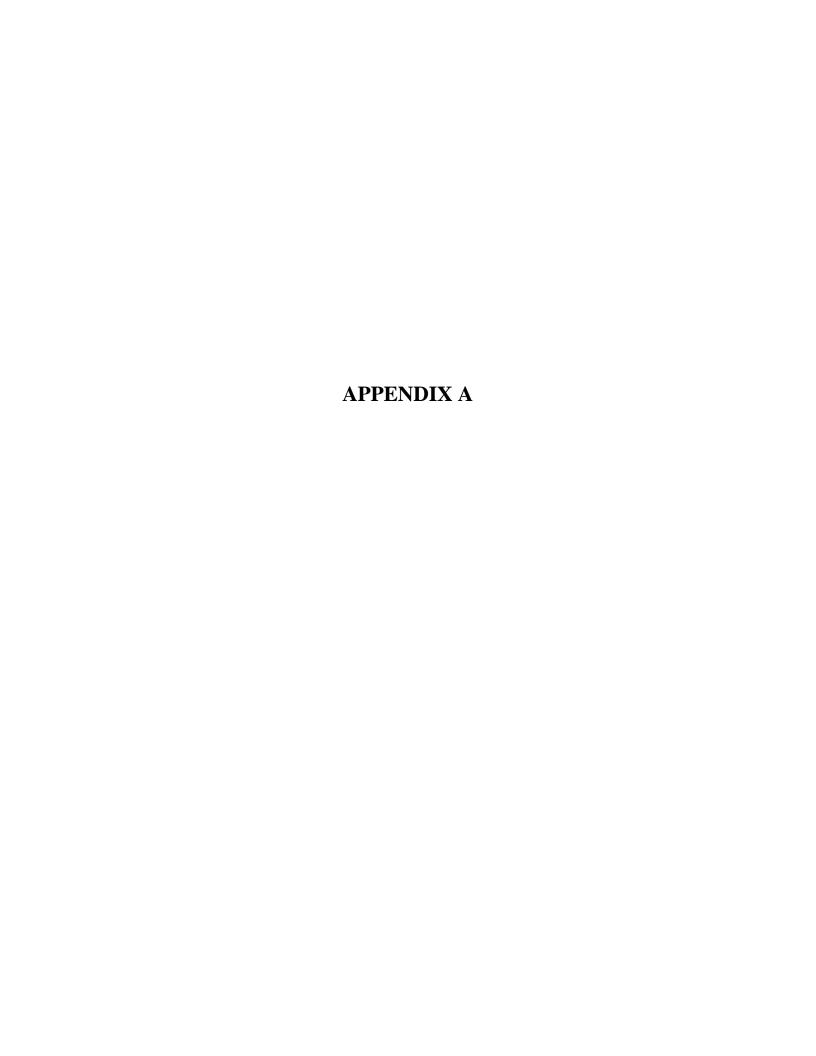


