Enable Mississippi River Transmission, LLC ("MRT") hereby electronically submits for filing with the Federal Energy Regulatory Commission ("Commission") its Annual SCT Revenue Crediting Filing ("Annual Filing") in accordance with MRT's Supplement to Stipulation and Agreement in Docket Nos. RP20-212-000, RP20-131-000, *et seq.* ("Settlement Filing").

STATEMENT OF NATURE, REASONS AND BASIS

Pursuant to Article II.B.3 of the Settlement Filing, within 90 days of the conclusion of a calendar year (beginning with calendar year 2019), MRT shall provide to the SCT customers with contracts listed in Supplemental Appendix B of the Settlement Filing¹ a report showing any SCT base rate revenue MRT collected from such contracts during the prior calendar year in excess of \$400,000 (SCT Base Rate Revenue Cap). MRT shall credit any such base rate revenue collected above the \$400,000 SCT Base Rate Revenue Cap on a pro rata method to each SCT customer whose SCT contract is listed in Supplemental Appendix B of the Settlement Filing based on such customer's share of contribution to SCT total base rate revenues during the prior calendar year. MRT submits herewith that the SCT total base rate revenue for the period January 2023 through December 2023 was \$194,718.90. Included as Appendix A to the instant filing is a schedule supporting that the calculation is not in excess of the SCT Base Rate Revenue Cap. Therefore, in accordance with the Settlement Filing, no credit is required.

REQUEST FOR WAIVERS

Although MRT is unaware of any waivers which are required, MRT respectfully requests that the Commission waive any parts of its Regulations as may be required to accept the instant filing.

CONTENTS OF THE FILING
