Enable Mississippi River Transmission, LLC ("MRT") hereby submits for filing with the Federal Energy Regulatory Commission ("Commission") the revised tariff records to its FERC NGA Gas Tariff, Third Revised Volume Filed Agreements ("Filed Agreements Tariff"), which are listed in Appendix A, proposed to become effective on April 1, 2025.

#### **STATEMENT OF NATURE, REASONS AND BASIS**

The purpose of this filing, made in accordance with the Section 154.204 of the Commission's Regulations, is to propose administrative housekeeping revisions to MRT's Filed Agreements Tariff. MRT recently performed a review of its negotiated rate and non-conforming agreements to determine if any agreements are no longer required to be listed in its Filed Agreements Tariff. After such review, MRT has identified several agreements which have terminated by the terms of the individual contracts, or which have been modified such that they are no longer classified as negotiated rate agreements. Therefore, MRT is proposing to cancel the tariff records which reference the expired or modified negotiated rate and non-conforming agreements.

Additionally, the Table of Contents is being updated to reflect the removal of the cancelled tariff records.

#### **IMPLEMENTATION AND WAIVER REQUEST**

Pursuant to Section 154.7(a)(9) of the Commission's Regulations, MRT requests that the proposed tariff records submitted herewith be accepted effective April 1, 2025. MRT respectfully requests that the Commission grant any waivers of its Regulations that it deems necessary in order to accept this filing and allow the proposed tariff records in this filing to become effective on April 1, 2025.
