Dear Ms. Bose:

Enable Mississippi River Transmission, LLC ("MRT") hereby submits its filing in compliance with Order No. 587-Z,¹ which the Federal Regulatory Commission ("Commission" or "FERC") issued on July 15, 2021. MRT respectfully requests that the Commission accept the following tariff sheets to be included as part of its FERC Gas Tariff, Sixth Revised Volume No. 1 ("Tariff") to be effective June 1, 2022:

I. Statement of the Nature, the Reasons, and the Basis for Proposed Changes

On July 15, 2021, the Commission issued Order No. 587-Z, amending its regulations to incorporate by reference the latest version (Version 3.2) of certain business practice standards applicable to interstate natural gas pipelines and adopted by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB").² The NAESB WGQ Version 3.2 package of standards includes revised and new WGQ Electronic Delivery Mechanism ("EDM") Related Standards and WGQ Internet Electronic Transport ("IET") Related Standards in response to recommendations stemming from the Sandia Surety Assessment.³ Additionally, Version 3.2

contains new and revised NAESB Standards that respond to requests for modifications made by participants in the WGQ or are the result of normal WGQ activities.

The revisions to the WGQ EDM and WGQ IET Related Standards include new Standards 4.3.109 and 10.3.28, which impose requirements on Trading Partners regarding vulnerability evaluation and implementation of fixes and patches. Additionally, new Standards 4.3.110 and 10.3.29 provide that Trading Partners should mutually agree on the versions of EDM and IET Related Standards to be used in their transactions, along with specifying notification and coordination timelines with Trading Partners and other system security measures.

Other NAESB Standards were revised in response to the Sandia Surety Assessment, including 4.3.60, 10.2.33 and 10.3.25. Further, NAESB deleted Standard 4.3.83 to remove legacy support references and to maintain a minimum encryption strength of 128 bits.

NAESB Standards 10.2.34 and 10.3.15 were revised to delete a proprietary Pretty Good Privacy ("PGP") hyperlink and to accommodate license-free OpenPGP, respectively. New Standard 10.2.39 was adopted to specify that OpenPGP be used to create public and private keys for privacy and digital signature applications. Finally, NAESB revised Standards 4.3.60, 4.3.84, 10.3.4 and 10.3.16 to require that Hyper-Text Transport Protocol Secure, or HTTPS, be used whenever secure communication is required.

The modifications to NAESB Standards made in response to industry input or in the course of routine WGQ activities include revisions to Standards 1.3.27, 1.4.1 and 1.4.2 to allow Service Requesters to customize nominations for segmentation transactions via an automated procedure. Additionally, new Standards 4.3.107 and 4.3.108 were added to establish standard data retention periods for retrieval of Operationally Available and Notices data, respectively. Finally, NAESB revised Standards 1.3.14, 1.3.15, 1.3.82 and 3.3.3, along with Data Sets 0.4.1, 0.4.2, 0.4.3, 1.4.1, 1.4.3, 1.4.4, 1.4.5, 1.4.6, 2.4.1, 2.4.6, 2.4.17, 3.4.1, 3.4.2, 5.4.24, 5.4.25 and 5.4.26 to remove outdated and addupdated references.

Order No. 587-Z requires each interstate natural gas pipeline to file tariff records to reflect the Version 3.2 standards by November 12, 2021. The standards are to be implemented June 1, 2022.

II. Changes to Implement Version 3.2 Standards

MRT has revised the language of Section 2.3, GT&C, on Sheet Nos. 105 and 111 to conform to the language in the sample tariff record the Commission posted on its eLibrary website under Docket No. RM96-1-042. Additionally, MRT proposes to incorporate by reference the new NAESB Version 3.2 Standards 4.3.107, 4.3.108, 4.3.109 and 4.3.110 on Sheet No. 113. MRT also removed Standards 4.3.61⁴ and 4.3.83 from the list of standards on Sheet No. 113. The final revision to Sheet No. 113 is the addition of Standard 4.3.31, which MRT noticed during preparation of this filing had been inadvertently omitted.

Sheet No. 114 has been revised to incorporate new Standards 10.2.39, 10.3.28 and 10.3.29 by reference. To aid in the Commission's review of the filing, MRT is including for convenient reference in Appendix C hereto the remaining Tariff sheets that comprise Section 2.3, GT&C of its Tariff regarding applicable NAESB Standards that were not affected by the adoption of Version 3.2 of the NAESB Standards.

- 2.7 Customers will be required to utilize MRT's Internet web site to request service, and execute and amend Service Agreements, to the extent that MRT's Internet web site has the capability to accommodate such contract execution, unless MRT otherwise agrees or emergency events prevent such electronic communication. Electronic transactions between Customer and MRT shall be binding and enforceable in the same manner and to the same extent as written transactions, and evidence of electronic transactions, if introduced on paper will be admissible to the same extent as other business records originated in written form.

- 2.9 MRT shall notify Customers of intraday bumps, OFOs and other critical notices (as defined in this tariff) in the manner provided in this tariff unless the Customer has provided MRT with a written request specifying that EDI or Internet e-mail (up to two Internet e-mail addresses) notification be used. Intraday bump notices should indicate whether daily penalties will apply for the gas day for which quantities are reduced.
- 2.10 Emergency Events. The requirements to nominate and implement capacity releases, execute contracts or provide other information electronically set forth in this Tariff shall be inapplicable in an emergency event, which shall be a failure or disruption of Customer's or MRT's electronic communication equipment (including temporary events such as system crashes, outages, or slow response time), Internet, or third party service provider or other similar emergency event which constitutes an event of force majeure as defined in Section 12.1 of these General Terms and Conditions. 

- 2.9 MRT shall notify Customers of intraday bumps, OFOs and other critical notices (as defined in this tariff) in the manner provided in this tariff unless the Customer has provided MRT with a written request specifying that EDI or Internet e-mail (up to two Internet e-mail addresses) notification be used. Intraday bump notices should indicate whether daily penalties will apply for the gas day for which quantities are reduced.
- 2.10 Emergency Events. The requirements to nominate and implement capacity releases, execute contracts or provide other information electronically set forth in this Tariff shall be inapplicable in an emergency event, which shall be a failure or disruption of Customer's or MRT's electronic communication equipment (including temporary events such as system crashes, outages, or slow response time), Internet, or third party service provider or other similar emergency event which constitutes an event of force majeure as defined in Section 12.1 of these General Terms and Conditions.
