Note: EGT has limited displacement capacity from West 1, West 2, Neutral (Flex), North, and South points. Displacement capacity will be evaluated on a day-to-day basis.

Note: Due to high utilization, EGT has limited capacity for IT and Secondary services from West 1, West 2, Neutral (Flex) and North Pools to The Perryville Hub and other South Pool deliveries. Shippers should nominate in accordance with their contractual rights.

EGT Estimated Available Capacity (DTH)

Based on current conditions, EGT estimates that the following incremental firm and/or interruptible capacity may be available for the gas day(s) specified above.
